QUESTIONS AND ANSWERS

Question 1:

Answer:

Yes, if desired, Proponents may separate out flea treatments in their response and communicate that in the updated APPENDIX D FINANCIAL SUBMISSION under added table **Optional Pricing – Fleas Only**.

Question 2:

Can there be a category for exterior treatment be added in the Earwig, Ants, Fleas, Silverfish, Spiders Category page 20-21 as spiders and ants often require exterior treatment.

Answer:

A separate line has been added to the updated APPENDIX D FINANCIAL SUBMISSION, table **Earwigs**, **Ants**, **Fleas**, **Silverfish**, **Spiders**. Proponents are asked to please provide a price for exterior treatment when working with the removal of spiders and ants.

Question 3:

If a unit is "unit not prepared at all" or "access is refused by tenant" will DNSSAB approve full price charge or a modified price for pest control company's time? Realistically, this is lost time and revenue for the pest control company

Answer:

A separate table has been added to APPENDIX D FINANCIAL SUBMISSION where proponents are encouraged to put in a cost for "unit not prepared at all" or "access is refused by tenant". DNSSAB will approve a modified price in these situations which will cover time lost by the vendor.

Question 4:

We were unsuccessful in the bid for proactive pest control. I just wanted to make sure that we had all the necessary documents and accreditations etc. for the application. We understand of course if the decision was made due to other factors, but before we submit for the reactive pest control opportunity

Answer:
